By submitting an entry form I accept that I am deemed to recognise the advantages of participating in a Society Approved sale and in consideration thereof I agree to be bound by these General Conditions and by the said Special Conditions and accept the decisions of the Sale Committee as final and binding insofar as they affect or relate to any entry of mine.</p> <p>(2) I acknowledge that the Society has total and unfettered control over the entry of animals to be offered for sale.</p> <p>(3) I accept that all entries will be subject to inspection by inspectors appointed by the Sale Committee for the purpose of ensuring that each entry satisfies the inspection prerequisites set out in the Special Conditions of Entry and Sale.</p> <p>(4) I accept that the inspectors may reject any entry if in their opinion it does not satisfy the inspection criteria. I agree to immediately remove any entry rejected by the inspectors to a holding area as directed.</p> | <p>(5) I agree that the decision of the inspectors as relayed to me by the Sale Committee is final and binding upon me.</p> <p>(6) I hereby irrevocably release the inspectors, the members of the Sale Committee (including any veterinarian or other person acting on behalf of the Sale Committee) and the Society from all claims, actions and demands, damages and expenses which I may have against any of them but for this release.</p> <p>(7) I certify that the information supplied on the entry form is correct in every respect and in consideration of the Society accepting my entry I agree to accept responsibility for and to indemnify the Sale Committee and the Society against all liability arising as a consequence of any such information being misleading or otherwise not correct.
